

2024 Release and Application Regarding Youth Deer Hunt on Henry County Water Authority Property:

Regulations for Youth Deer Hunting

The undersigned does hereby acknowledge that the Henry County Water Authority (hereinafter 'Authority') is allowing them and their minor child(ren) to participate in a managed hunt(s) of white-tailed deer on property owned by the Authority. The undersigned does hereby release and discharge the Authority, its officers, directors, managers, employees and members of the Board of and from any and all claims arising out of or by virtue of the undersigned and their minor child(ren) being allowed to hunt on said property. This release is executed by the undersigned, for and on behalf of the undersigned, his or her heirs, successors, representatives or assigns, and is intended to be a full and complete release of the Authority of any and all claim that the undersigned may now or hereafter have against the Authority arising out of, or in any way connected with the undersigned's presence on the property of the Authority for purposes of participating in a managed deer hunt(s).

The undersigned acknowledges that he/she is a mere licensee whose right to remain on the property of the Authority is terminable at will and without notice. The undersigned agrees to vacate the property at such time(s) as the Authority or its representative in sole discretion determines is appropriate.

The undersigned expressly assumes all risks and damages incidental to the white-tailed deer managed hunt(s) conducted on the property of the Authority. The undersigned agrees and stipulates that the Authority, its officers, agents, employees, and Board Members are not responsible or liable for any injuries sustained or illnesses contracted, including Covid-19 and does hereby release any claim against them arising directly or indirectly from any such injury.

As evidenced by the below signature the signee has read and agrees to abide by the above release and all regulations governing the hunts on Authority Property to include both state law and special regulations set by the Henry County Water Authority.

1. **Hunters are responsible to insure that they have the proper license; all state laws and license requirements are enforced.**
2. **Hunters must use personal state issued deer tags.**
3. **Only shotguns will be permitted for Youth Deer Hunt. Buckshot ONLY. No slugs.**
4. **All shotguns are to be cased when not in blind.**
5. **Only deer may be harvested.**
6. **Youth must be between 10-17 years old.**
7. **Alcoholic beverages are not permitted on Authority property.**
8. **Hunters must remain in designated area for duration of hunt. HCWA staff will escort hunters in and out of hunting area.**
9. **All hunters are required to have a working cell phone.**
10. **All hunters are required to wear 500 sq. inches of orange above the waist at all times.**
11. **All hunting locations are assigned by lottery and hunters will be taken to and picked up from their hunting locations by HCWA staff.**
12. **Only ground blinds will be allowed for this hunt. Blinds will be provided and set up by HCWA staff prior to hunt.**
13. **All deer must be brought to the check station before being field dressed by the hunter.**
14. **NO tracking of deer will be allowed without accompaniment of HCWA staff member.**
15. **Any hunter who violates state law or special regulations set forth by the Henry County Water Authority is subject to losing their hunting privileges on Authority property, which will result in forfeiture of the hunt.**
16. **By signing the waiver, I hereby grant HCWA and their representatives permission to take and publish photographs of me at this event.**
17. **All trash/litter must be self-contained and disposed of properly.**
