HCWA asking customers to use water wisely Outdoor water use schedule: daily after 4:00 p.m. and until 10:00 a.m.

With dry, hot weather expected to continue for the next few months, the HCWA is reminding customers to use water wisely.

As a reminder, the current outdoor water use schedule allows for daily watering from 4:00 p.m., thru the overnight hours, and until 10:00 a.m.

Some additional tips and reminders to help consumers save water include:

- New homeowners remembering to check their irrigation system to make sure they are set properly and not leaking.
- Using more drought-resistant plants within landscapes, as well as mulch or straw around plants to retain moisture, and a rain barrel to capture rain for watering.
- · Finding and fixing household leaks as they occur. (See story on "Leak Detection.")
- Considering the installation of water-efficient appliances, especially low-flow toilets.
- Taking shorter showers instead of baths and turning off the water while brushing your teeth or lathering your hands when washing.
- · Using the dishwasher and washing machine only when they are full.

Leak Detection: finding and fixing these sources of water loss

In addition to adhering to the outdoor watering schedule (daily from 4:00 p.m. to 10:00 a.m.), please check your home for household water leaks.

Here are some easy steps to take to see if you have a household leak:

- 1. Locate your water meter in the Meter Box near the curb of your home.
- 2. Write down the number or reading on your meter.
- 3. Make sure there is no water running in the house.
- 4. After a few minutes, recheck the reading on your meter. If that number has changed, you have a household leak.

If you find and fix your household water leak, you may be eligible to receive a leak discount or credit on your account.

Water Quality Report shows your tap water is clean and safe to drink

The HCWA has released the 2024 Henry County Water Quality Report, also called a Consumer Confidence Report (CCR), which provides scientific data that we are producing the highest quality tap water possible.

The Water Quality Report includes water quality data collected from Jan. 1 – Dec. 31, 2023, which reveals that the HCWA had no violations of permitted levels of regulated substances (potential contaminants) in its tap water this past year.

Regulated substances for which regulatory agencies require testing - because of their potential to cause contamination if they exceed permitted levels – include those categorized as organic, inorganic, microbiological, or as the result of disinfectants or disinfectant by-products used in the drinking water treatment process.

For public water utilities such as the HCWA, annual Water Quality Reports are required to inform consumers of "What is in my drinking water and why?" and ultimately, "Is my water safe to drink?" The intent of these annual reports is to increase the public's "right to know" about the nature and contents of their drinking water, so they might make informed health decisions about tap water consumption.
