

WATER QUALITY REPORT PROVIDES EVIDENCE OF HCWA TAP WATER SAFETY

We have published our annual Henry County Water Quality Report to provide scientific evidence that we have the highest quality tap water possible, while offering our customers the peace of mind that comes from knowing your drinking water is safe to drink.

The 2023 Henry County Water Quality Report includes extensive results of laboratory data collected from water quality tests conducted during the 2022 calendar year, which indicate that we have no violations of permitted levels of regulated substances in our tap water.

Those regulated substances are categorized as organic, inorganic, microbiological, or as the result of disinfectants or disinfectant by-products used in the drinking water treatment process. The lab data includes measures of these regulated substances found at the source, during drinking water production, and within the HCWA distribution system.

REMEMBER OUTDOOR WATERING SCHEDULE AND WISE WATER USE TIPS

Remember, the current outdoor water use schedule allows for watering between the hours of 4:00 p.m. to 10:00 a.m., which is the ideal time to water outdoors anyway, to reduce evaporation.

HUNTING SEASON FEATURES TWO YOUTH HUNTS AND A VETERAN'S HUNT

Applications for the lottery for participants closes Sept. 22

The 2023 HCWA Hunting Season will consist of two Youth Hunts for kids between the ages of 10-17, on the Saturdays of Oct. 21 and Nov. 4, as well as a Veteran's Hunt for those honorably discharged, active duty, or reservists, on Saturday Nov. 18.

FINANCIAL ASSISTANCE AVAILABLE TO CUSTOMERS FACING HARDSHIP

There are several ways HCWA customers can receive financial assistance, thanks to our partnerships with local non-profit organizations and agencies.

First, generous customers who "round up" their monthly bill provide funds for our Charitable Assistance Program (CAP) to help other customers pay their monthly water bill. Our CAP is administered by our friends at Connecting Henry, who you can contact at 770-274-3642 or www.connectinghenry.org.

Second, we can direct our customers to the Henry County Emergency Rental Assistance Program (ERAP), which provides financial assistance for rent, utilities (including water), and security deposits. For more information, call 855-436-7926 or go to www.henryerap.org.

Third, the Low-Income Household Water Assistance Program (LIHWAP) is a federal program to help low-income residents pay for water and wastewater services, if those utility bills are in your name, and you can verify a financial burden.
