HCWA hosts approximately 3,000 third grades for field trips at Cubihatcha

This fall, HCWA staff and volunteer faculty welcomed more than 3,000 Henry County third graders and their teachers to the Cubihatcha Center in Locust Grove for classes and

These annual field trips for the "Cubihatcha Kids" were established by the Henry County Outdoor Education Partnership, a non-profit formed by the HCWA, Henry County Board of Education, and others.

The event provides these students with opportunities for experiential or "hands-on" learning of the third grade Georgia Standards for Excellence and Applied STEM curricula.

Drinking Water Safety includes protection from lead and copper

According to federal regulations for drinking water safety, water utilities such as the HCWA must check the water lines in their distribution system and among customer homes to determine if lead and/or copper are present.

The HCWA met the Oct. 16th deadline for completing this system review, and officials are happy to report they did not identify any lead service lines within the HCWA system.

Lead in water is caused by corrosion of older pipes, plumbing fixtures, and faucets, typically limited to homes built prior to 1986. The HCWA has been testing for lead in our water for years, and we have had no water quality violations as a result.

Remember, the HCWA owns and maintains the water lines from our water plants and distribution system all the way up to your meter, but the water lines from your meter to inside your home are your responsibility.

The importance of water pressure and Pressure Reducer Valves

Water pressure can create challenges for a water utility and its customers, which is why we encourage you to adhere to home plumbing standards and make sure you have a pressure reducing valve (PRV) installed and operating properly at your home or business.

Because water coming into your meter may be under higher pressure than what's recommended for home fixtures and appliances, a PRV works directly to slow down the water pressure coming into your home.



Home fixtures and appliances are designed to withstand a certain level of water pressure, typically between 60-80 psi. These items can wear down if continually subjected to high pressures. So please make sure your PRV is installed and operating properly to



protect your property.

HCWA emergency response and disaster relief assistance began with Authority crews working with Henry County EMA officials to assist with calls from citizens reporting issues throughout the community, such as downed trees blocking roadways, severe flooding, power outages, and more, following Hurricane Helene.

In addition, the Authority's Todd Brackin, HCWA Conservation Enforcement Coordinator, delivered bottled water provided by the Authority for those in immediate need in South Georgia.

The HCWA then joined forces with other community partners to collect additional bottled water, food, non-perishable items, health and personal items, for citizens in Berrien County, Georgia.



This community food drive was spearheaded by American Legion Post 516, under the direction of Commander Alton Head, who is a Field Safety Inspector for the HCWA. Additional partners included Stockbridge Community Church and Pastor Jeff Davis, Henry County District 1 Commissioner Johnny Wilson, Henry County Public Safety, and other county departments, agencies, and community organizations.

Finally, HCWA staff from the Water Loss Department made their way to Atlanta Motor Speedway (AMS) to provide food for those who had evacuated Florida during Hurricane Milton.
